- 1. Contract: A contract must be completed by the party person and delivered to the studio, via email or postal service, 1 week prior to the event. The painting theme/ art lesson must be decided by this time.
- 2. **Non-Refundable Deposit**: Events require a \$50 deposit to reserve the date and time with the remaining balance due on the day of the event. Nonrefundable deposits can be applied to another event or art class if it is held within one month of your originally scheduled event date (availability permitting).
- 3. **Event Rates:** The rate will be \$20 per painter. Schools will be charged according to the final count of guests registered to the event. There is a 20 guest minimum per event.
- 4. **Sunday Events:** Sunday events are a custom scheduled time. There will be an additional \$50 fee for events held on Sundays.
- 5. **Travel Fee:** The travel fee to your location will be an additional \$50.00.
- 6. **Custom Designed Themes:** \$20.00 extra Custom themes are considered as lengthy lessons or themes we must design or re-edit often upon your request to match your request
- 7. **Additional Time:** Each additional half hour following the allotted 1.5-hour time of the party is \$50.00.
- 8. **Materials:** We prepare our art materials for events according to the number of guests given to us 3 days prior to the event and charge accordingly. We cannot reimburse for materials or count of guests once the final count has been submitted to us 3 days prior to the event.
